### Terms and regulations for Buyer's participation - European Subcontracting Matching Stuttgart, November 7<sup>th</sup> and 8<sup>th</sup> 2018

#### 1.) Organisation

The European Subcontracting Matching Events are organised by Europass Srl, Via delle Mimose 2/a, 31033 Castelfranco Veneto (TV) - Italy (hereinafter referred to as the "Organiser").

#### 2.) Purpose

These regulations define the conditions under which Europass Srl organises and operates these events. They specify the respective duties and rights of the Participant (Buyer) and the Organiser. The Participant formally undertakes to respect these regulations. The description of the service supplied to the Buyer is available on the official Event brochure, which can be downloaded from the website [www.esm-agenda.com](http://www.esm-agenda.com).

#### 3.) Place and date

The ESM Event will take place in Stuttgart, on November 7<sup>th</sup> and 8<sup>th</sup> 2018 at the at the Wöllhaf Konferenz und Bankettcenter Stuttgart Airport. In case of situations out of the Organiser's control, which renders the site impossible to use, the Organiser has the right to defer the date and/or change the site. The Organiser may cancel the event having notified the Participant and in this case, the present Buyer's registration form will then be cancelled without compensation for the Participant except for the reimbursement of the registration fee already paid.

#### 4.) Admission, modification, cancellation

The Organiser reserves the right to refuse a Buyer's registration form for whatever reason without justifying its decision. In case of the Buyer's withdrawal before October 5<sup>th</sup> 2018, the signer of the registration form will be reimbursed 100% of the amount specified in the registration form, if already paid. The Buyer's withdrawal can only be transmitted to the Organiser by registered letter. After this date, the registration to the ESM in Stuttgart, is definitive and irrevocable and the Participant owes the complete amount of the participation fee.

#### 5.) Company data, material sent, information, interviews, videos

The Buyer's company information shall be treated according to the latest governing law at the time of signing of this present document and for the organisation of the ESM and SOH events. As regards company information, material sent to the Organiser, logos, interviews released during the event, it shall be the Buyer's responsibility to limit their eventual use while forwarding the registration form and/or a request for quotation. Any eventual limitations must allow the Organiser to carry out in full the activities for organising meetings and promoting the event. Under no circumstances the Organiser shall publish the names of the Buyers for commercial purposes or to promote the event without written consent of the Buyer. The Organiser is free to publish any photos and/or videos of the event for promotional purposes.

#### 6.) Services included and prices for Buyer's participation

The Buyer's participation fee is € 90.- (VAT excl.) per day/Buyer. The price includes the above mentioned services. The participation fee must be paid by SWIFT bank transfer upon receiving the invoice.

#### 7.) Other commercial rules

It is forbidden for Participants to allow any other company to benefit from all or part of the services offered by ESM Events without the prior consent of the Organiser.

#### 8.) Non-obligation clause

The Organiser will commit itself to the success of the event diligently and to its fullest capacity, however no responsibility is taken for results.

#### 9.) Insurance

As the Organiser, Europass Srl is civilly responsible for this event. This responsibility in no case covers damages caused by a third party to the Participants. The event site meets its civil responsibilities as owner of the buildings and installations, fixed or temporary, used for the exhibition. The Participant is responsible for all damages caused to others by himself, his staff or his installations. The Participant must be covered by a civil responsibility insurance, and insure the equipment belonging to him and brought to the event.

#### 10.) Application of the regulations

The Organiser has the right to rule on all cases not covered in the present regulations and to make any necessary modifications or additions, which then immediately come into force. The circulars sent to Buyers later are an integral part of the present regulations. Any infringement of the present regulations may incur the exclusion of the participating Buyer committing the infringement.

#### 11.) Powers

By signing the registration form, the Participants declare that they unconditionally accept the clauses in the present regulations. In case of dispute and before all proceedings, all Participants undertake to submit their complaint to the Organiser. In case of dispute, the sole competent court is the one of the Organiser.
